2009 EXHIBITOR CONTRACT

1. Grand Slam Club/Ovis reserves the right to adjust or make changes in booth assignments through January 5, 2009 to ensure an even flow of traffic or to maintain show character.
2. No exhibit shall be allowed to extend into the aisle beyond the space assigned. **Exhibitor constructed sidewalls more than 4 feet high cannot extend more than 5 feet from the rear of booth to allow unobstructed view of adjacent booths.** Exhibitors can distribute literature and materials from their booths only.
3. Grand Slam Club/Ovis reserves the right to prohibit any exhibit, exhibitor or proposed exhibit which in GSCO's opinion is not suitable for this exhibition. The reservation concerns persons, items, video or printed matter, conduct and all other things that affect the character of the exhibition.
4. **Non-exhibitor solicitation is strictly prohibited.**
5. Exhibits which include the operation of audio/visual or lighting equipment must be arranged so the noise/light from said equipment will not annoy or disturb any adjacent exhibitors or visitors.
6. Exhibitors will be notified by January 5, 2009 of registration and setup times. Failure to set up during the designated time may result in the loss of booth space and no refund of booth deposit.
7. All materials or decorations used in the booths shall be approved and/or flame proofed. Exhibitors using flammable materials must contact the fire department and be in compliance with the fire code.
8. Collection of applicable sales tax is the responsibility of the exhibitor making the sale.
9. No fundraising activities will be allowed in individuals' booths or in any part of the convention facility.
10. Exhibitors or agents shall not injure or deface the ceilings, walls or floors of the building, the booths or the equipment of the booths. The exhibitor will be liable if such damages occur.
11. The application for space and the formal notice of assignments by Grand Slam Club/Ovis and the full payment of booth space and rental fees constitute a contract for the right to use the space allotted.
12. The exhibitor agrees to indemnify and hold harmless Grand Slam Club/Ovis, Bally's Las Vegas, and the legal entities which own, lease, and/or operate Bally's Las Vegas, their members, officers, directors, and employees against any claim or liabilities imposed by law on account of property damage or bodily injuries, including death, resulting therefrom, sustained or alleged to be sustained by any person or persons, whether they be members of the public visiting the show, employees of Grand Slam Club/Ovis or other exhibitors, resulting from the negligence of the exhibitor, its agents, employees or persons performing services for it, or resulting from any equipment or machinery under control of the exhibitor.
13. The exhibitor assumes complete responsibility and liability for all injury to any and all persons or property in any way connected with the exhibitor's display caused by the exhibitor, his agents, representatives, or employees.
14. Notwithstanding any remedy available to the exhibitor at law, the exhibitor hereby expressly releases and waives any and all claims against Grand Slam Club/Ovis, its agents, officers, directors, members or employees in consideration of the mutual agreement of the parties and the opportunity of exhibitor to exhibit at the convention herein referenced.
15. This contract shall not be assigned, and no right granted to exhibitor in this agreement shall be subcontracted without the written consent of Grand Slam Club/Ovis.
